RULES

1. Competitors may enter ONE singles and doubles event.
2. Competitors must not have attained the age of 10, 12, 14, 16, 18 as of 1st January 2023, for entry in the respective age group. The committee has the right to request a competitor to produce his/her birth certificate.
3. Entry forms will only be available on our UTR website. You must sign up for your UTR account and then enter the respective event on Tennis Patrons UTR Site.
4. The draw will take place at the Public Court on **Tuesday 4th July 2023 at 4:00pm.**
5. **COMPETITORS ARE EXPECTED TO WEAR PROPER TENNIS ATTIRE WITH NO ADVERTISING OF ANY KIND, SLOGAN OR WRITING MORE THAN 2X2 Sq. inch. NO T-SHIRTS OTHER THAN THE SPONSOR WILL BE ALLOWED. ALL COMPETITORS RECEIVING PRIZES MUST BE AT THE CLOSING CEREMONY WITH THE TOURNAMENT T-SHIRT.**
6. Entries close on Sunday 2nd July 2023 at 8:00pm. Entry Fee is \$150
7. At the discretion of the referee, competitors may be penalized for code of conduct violations on and off court in accordance with the **ITF Junior Circuit Code of Conduct** – <https://www.itftennis.com/en/about-us/governance/rules-and-regulations/>
 - a. Of particular interest to note are : **Article III Onsite Offences, and Article IV Major Offences**
 - b. Specific Article III Clauses that Tennis Patrons Academy will be ensuring are enforced: **Clause G. VERBAL ABUSE (VA); K. COACHING AND COACHES (CC) and Q. CEREMONIES (CER)**
 - c. Specific Article IV Clause that Tennis Patrons Academy will be ensuring is enforced: **A. AGGRAVATED BEHAVIOUR**
8. **All SCORING FORMATS ARE SUBJECT TO CHANGE BY THE TOURNAMENT COMMITTEE IF NECESSARY TO COMPLET THE TOURNAMENT.**
9. **U10's RR** scoring would be best of 3 short set, 4-4 tie-break and a 10 point match tie-break at set all. With No-Ad scoring
U12's RR and Main Draw would be best of 3 short set 4-4 tie-break and a 10 point match tie-break at set all. With No-Ad scoring
U14's RR would be best of 3 short set 4-4 tie-break and a 10 point match tie-break at set all. Main Draw Best of 3 set, tie-break at 6-6 and a 10 point match tie-break at set all. With No-Ad scoring.
U16's & 18's/21's Main Draw Best of 3 set, tie-break at 6-6 and a 10 point match tie-break at set all. With No-Ad scoring.
